Cancellation is possible by June 30 and December 31. A change to inactive membership is possible on the first of every quarter, and to active membership on the first of every month. New members have the right to terminate their membership within the first three months at the end of the third month. Applications for a change of status or termination must be submitted in writing to the office at least 6 weeks before the intended date.

I will notify the office in writing in a timely manner of any changes in group membership, the account I have given, my address or telephone. Number.

Each active member is entitled to 38 training units. In principle, the guided training takes place outside the school vacations NRW. Each adult member up to 70 years of age is required to provide 5 hours of assistance per calendar year. If I do not provide these hours, the association is entitled to collect a substitute amount from my account according to the contribution regulations.

Information obligations according to Article 13 and 14 DSGVO

According to Articles 13 and 14 EU-DSGVO, the controller (specifically TGC Rot-Weiß Porz e.V.) must provide a data subject whose data it processes with the information specified in the articles. This information obligation is fulfilled by this leaflet.

The TGC Rot-Weiß Porz e.V., Fauststr. 90, 51145 Cologne, is legally represented by the board of directors according to § 26 BGB, Patric Paaß, Heike Bender and Ulf-Daniel Jose; e-mail: info@tgc-porz.de.

At present, our association does not need a data protection officer. Should this change, it will be announced here. Until then, questions/concerns regarding the topic "data protection" may be directed to info@tgc-porz.de.

The personal data will be processed for the implementation of the membership relationship (e.g. invitation to meetings, collection of dues, organization of sports operations).

Furthermore, personal data will be forwarded to the state professional association (Tanzsportverband Nordrhein-Westfalen e.V.) and the federal professional association (Deutscher Tanzsportverband e.V.) for participation in competitions, tournaments and sports operations, as well as to the sports associations (Stadtsporbund Köln, Landessportbund Nordrhein-Westfalen).

In addition, personal data in connection with sporting events, including reporting on them, will be published on the website of the club, in appearances of the club in social media as well as on pages of the professional associations and transmitted to local, regional and national print media.

As a rule, the processing of personal data is carried out on the basis of necessity for the performance of a contract pursuant to Article 6 (1) b) DSGVO. The contractual relationships are primarily the membership relationship in the club and participation in the sports operations of the professional associations.

If personal data is collected without the processing being necessary for the fulfillment of the contract, the processing is based on consent pursuant to Article 6 (1) a) in conjunction with Article 7 DSGVO.

The publication of personal data on the Internet or in local, regional or national print media is carried out to protect the legitimate interests of the association (see Article 6 (1) f) DSGVO). The legitimate interest of the association is to inform the public by reporting on the activities of the association. In this context, personal data including pictures of the participants are published, for example, in the context of reporting on sporting events of the association.

Personal data of the members, who participate in the sport and competition enterprise of the national professional associations, are passed on for the acquisition of a license (e.g. tournament leader license, evaluation judge license), a valuation map (e.g. DTSA acceptance), or other participation authorization (e.g. start license) to the respective national professional association.

The data of the bank details of the members will be forwarded to the Sparkasse Köln-Bonn for the purpose of collecting the membership fees.

The personal data is stored for the duration of the membership.

Upon termination of membership, the data categories are retained for a further ten years in accordance with the statutory retention periods and then deleted. In the period between termination of membership and deletion, the processing of this data is restricted.

Certain categories of data are stored in the association archive for the purpose of the association chronicle. These are the categories first name, last name, membership of a team, special sporting successes or events in which the person concerned has participated. The storage is based on a legitimate interest of the club in the contemporary documentation of sporting events and successes and the respective composition of the teams.

All data of the other categories (e.g. bank data, address, contact data) will be deleted upon termination of membership.

The data subject (the member) is entitled to the following rights under the conditions specified in each of the articles:

- the right to information according to Article 15 DSGVO,
- the right to rectification in accordance with Article 16 DSGVO,
- the right to erasure according to Article 17 DSGVO,
- the right to restriction of processing according to Article 18 DSGVO,
- the right to data portability according to Article 20 DSGVO,
- the right of objection according to Article 21 DSGVO,
- the right to lodge a complaint with a supervisory authority pursuant to Article 77 of the GDPR
- the right to revoke consent given at any time, without this affecting the lawfulness of the processing carried out on the basis of the consent until revocation.

Personal data is generally collected as part of the acquisition of membership.
